2. Any kind of misbehavior or misconduct may result in rejection of membership of BHRI. All disputes subject to jurisdiction of Dhaka only.
3. BHRI will not be responsible for any mis use of Identity Card issued to the Members during the course of their Membership with BHRI.
4. On expiry, the Identity Cards must be submitted to the National Admin. Office. After expiry, renewal is a must for regular membership
5. In case of change of address, Member should inform the same to the National Admin. Office.
6. In case of loss of the identity Card, inform the National Admin. Office in writing along with the G.D/F.I.R. immediately.
7. All BHRI members should contact their respective Area Units | State Units / National Admin. Office once in a month.
8. Applicant can use photocopy of the application form which will be duly acknowledged by the National Admin. Office once received duly filled in.
9. Strict action will be taken against the Member, if found guilty floating the rules and regulations of BHRI, and are also punishable under the Press & Societies Act.
10. If you have any doubt, question or problem, please contact BHRI National Admn. Office. All rights reserved to BHRI.
11. BHRI is in no way responsible for any member who works at any other human rights organization without informing the BHRI and is involved in any unpleasant incident to that organization.
12. If a member uses the name of BHRI to commit a criminal act somewhere, then of course BHRI is not responsible for it.
